Representative Courses Taught

Over the course of my career, I have taught over thirty different subjects across the curriculum, from Tax and Property to Civil Procedure and Remedies. I highlight below the courses I have taught in the past ten years:

- Introduction to the Study of Law (0 cr., annually) A week-long legal methods and professional identity orientation course which I originally developed as part of our academic success program but which I and co-teachers have evolved into a much broader introduction to law study and the profession.
- Family Violence (2-3 cr., annually) I have co-taught this course with a practicing attorney for over 20 years. The course provides intensive skills training in client interviewing and counseling, case preparation, and advocacy. Final exam includes a mock protective order hearing.
- Client Interviewing (1 cr., annually) I teach this skills-intensive course both as a required course for first-semester students in our summer-start program and as an upper-level elective.
- Entrepreneurial Lawyering: Solo & Small Firm Practice (2 cr., annually) I teach and supervise this unique summer law practice management program. Students write business plans for a law practice and present to members of the bar for feedback and mentoring.
- Logical Reasoning for Pre-Law Students (1 cr., every semester) I developed and teach this
 undergraduate LSAT preparation course offered through a number of undergraduate departments.
- International Field Experience Family Law (1 cr.) After teaching as a visiting professor at the Autonomous University of the Yucatan in 2016, I developed this spring-break service-learning program in Merida, Yucatan, Mexico, which I annually co-lead.
- Interprofessional Perspectives on Aging (1 cr., four semesters, discontinued) I helped to develop and co-taught this grant-funded, 1-credit-hour course, teaching students from law, medical, nursing, dental and pharmacy schools in interprofessional teams with service-learning components.
- Readings in Legal Scholarship (1 cr., In rotation) I developed and regularly teach this social justice readings seminar, which has now become a key offering in our cross-cultural requirement.
- Professional Responsibility (2-3 cr. In rotation) I have taught this required upper-division course nearly every year since 1989 and have written a textbook and a library of CALI lessons in the subject.
- Ethical Issues in Family Representation (2 cr. In rotation) I wrote and published a textbook on this topic and developed and regularly teach this specialized Professional Responsibility course.
- Lawyering Skills I & II (2-3 cr., as-needed) I have regularly taught this course to cover the course during other faculty emergencies or other faculty transitions.
- Juvenile Offenders & the Law (2 cr. One semester only) Co-taught with adjunct professor to provide support for online teaching during pandemic)
- Access to Justice Clinic (1-6 cr. Every semester) Teach and supervise students in this clinic which
 provides advice, referral, education and limited-scope representation to self-represented litigants.

Administrative Highlights

- Advocated for and led faculty to adopt a robust diversity and inclusion strategic plan, contributed

 for the law school community to honor our values of diversity, equity, and respect.
- Expanded the School of Law's philanthropic impact, securing two largest gifts in law school history; advocated for university support, securing half-million faculty salary supplement and funding to create new MLS degree program and Center for Law, Entrepreneurship, and Innovation.
