Developed supplemental bar preparation program for UMKC graduates, both first time bar takers and repeat bar takers. Developed innovative teaching techniques, such as mind mapping for the bar exam. Focus is on strategies and tactics to approach the fifteen substantive topics on the bar exam in Missouri and in other states where UMKC students may wish to become licensed to practice law. UMKC's first time bar passage rate improved from 67% to 98%. Active participants in the program have passed at a rate of 96% to 100% since 2007. Received referrals from the Executive Directors of the Missouri and Kansas Bar Examiners due to program's reputation.

Developed for-credit bar preparation course to give at risk students the opportunity for additional skill development prior to bar preparation. Developed intensive mini-term bar preparation course open to all students focused on development of multiple-choice test-taking skills.

Inaugural recipient of the Eleanore C. Blue Lawyering Skills endowed professorship honoring the first full-time female law faculty member of the UMKC School of Law and one of the first endowed chairs nationally specifically for Lawyering Skills faculty.

Administrative responsibilities as Director of Legal Writing included coordination of all aspects of the Legal Writing Program. Hiring and training of legal writing faculty and teaching assistants. Responsible for curriculum modification on on-going basis to meet students' needs. Developed all writing exercises, research exercises, brief and memo problems, and other teaching materials.

Teaching responsibilities have included Legal Analysis and Methods, Lawyering Skills I and II, Lawyering Skills Teaching Methods, Advanced Legal Writing: Litigation Drafting, Products Liability, Family Law, Civil Procedure, and the Summer Academic Support Program.

Developed and instituted program to assist at risk students by focusing on additional analytical skill development in the second semester of law school as part of their first-year legal research and writing course.
